# GSP - Background

- GSP jointly implemented by UNEP and UNDP, initiated with the objective of providing support to non-Annex I Parties in preparation of National Communications (NCs) and Biennial Update Reports (BURs)
- GSP provides technical support to all countries that approach the GSP team, and complements the work of other supporting bodies such as the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention
- GSP guided by an Advisory Committee composed of representatives from UNDP, UNEP, UNFCCC, GEF, CGE.

# Types of support provided by GSP

- Financial: Access GEF funds (through preparation of BUR proposals for funding)
- Support in development of appropriate and robust National Institutional Arrangements for climate change activities
- Technical: Support for the preparation of good quality NIRs, NCs, BURs, (I)NDCs
  - Regional and national training workshops
  - Preparation of guidance materials/publications
  - Review of draft reports/components; NIR, NC, BUR, Mitigation analysis, V&A assessment
  - Assist in identifying and vetting international experts to support countries
- Enhance knowledge management, best practices, communication and outreach
  - GSP website with information and materials, tools, relevant links, and country pages
  - Online learning modules and webinars
  - South-South cooperation

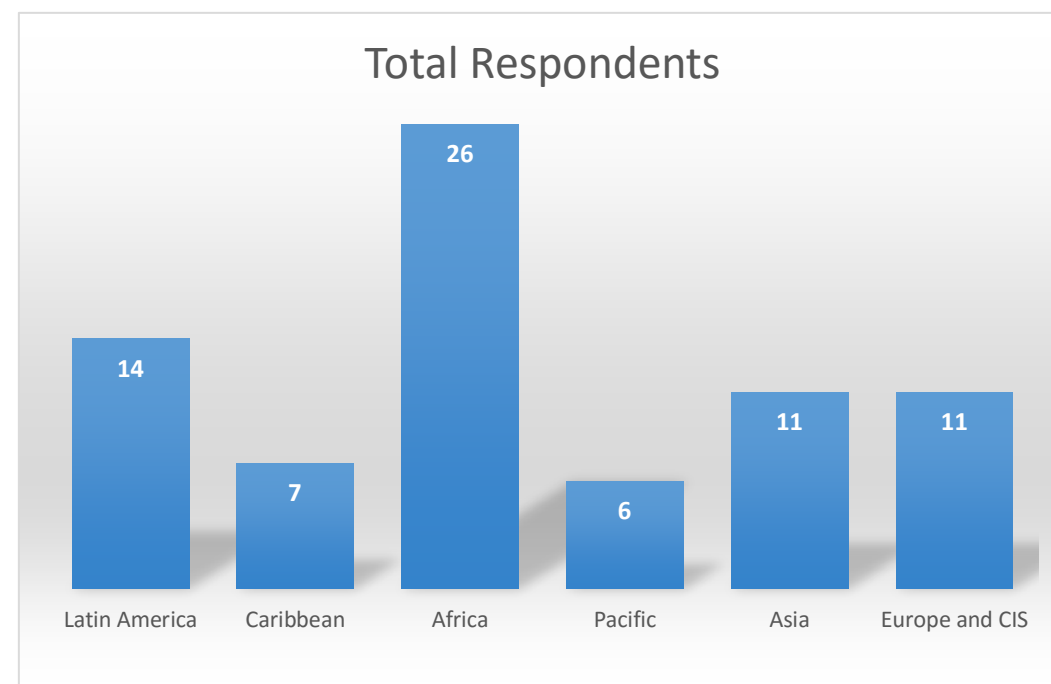
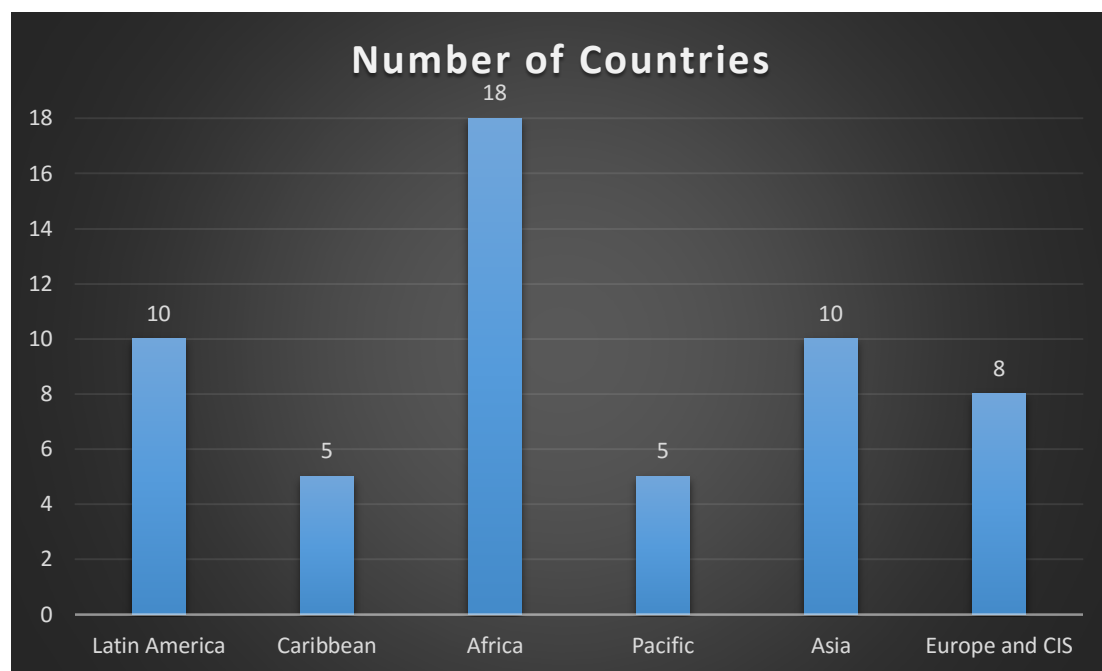
# GSP Alignment With the CGE

- Technical support built on activities and expertise already provided by the CGE:
  - eg. after regional workshops provide follow up to countries implementing BUR
  - GSP will help countries customize training based on national priorities – taking CGE training materials to the sub-regional (networks) and national level
- Collaboration with the CGE on specific activities
- Support the coordination and implementation at the national level
- Translation of key documents
- Assessment of requests at the sub-regional and national level for GSP or CGE support (a two way flow between GSP and CGE)

# GSP Survey on Capacity Building Needs

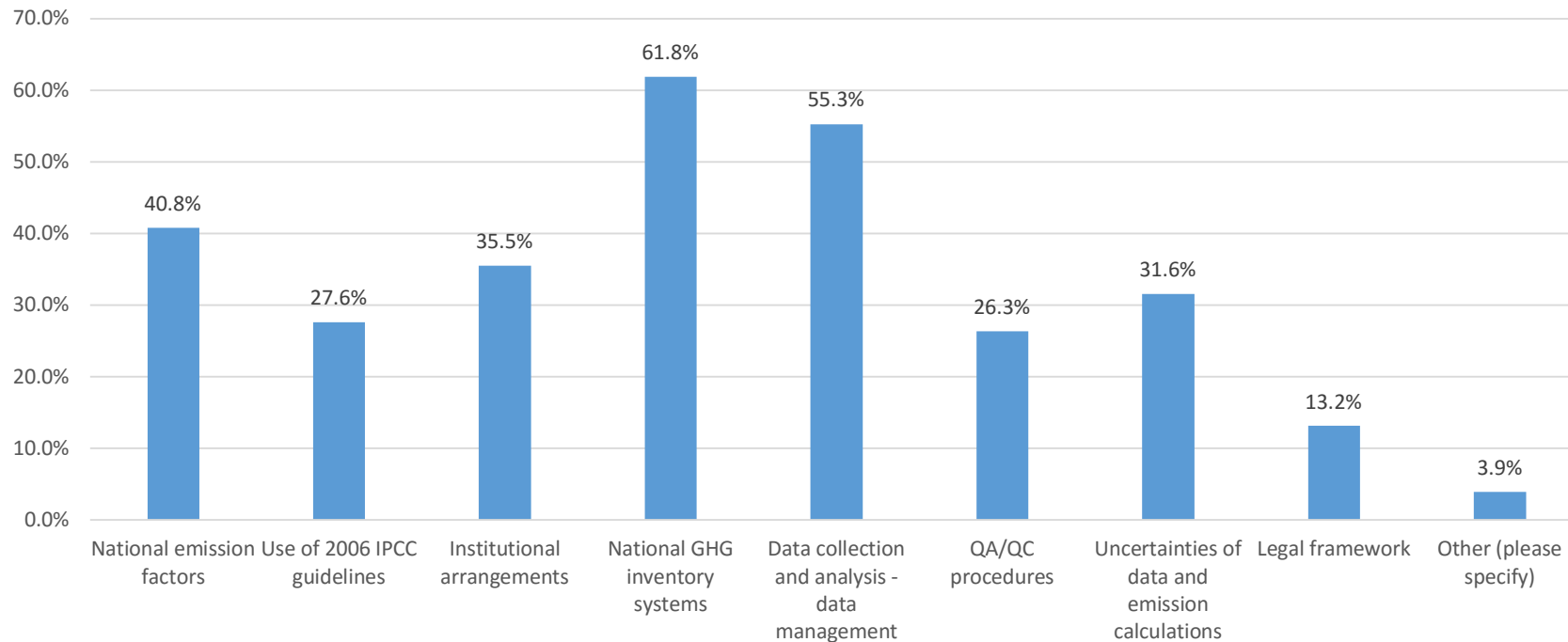
**56 countries filled the survey**

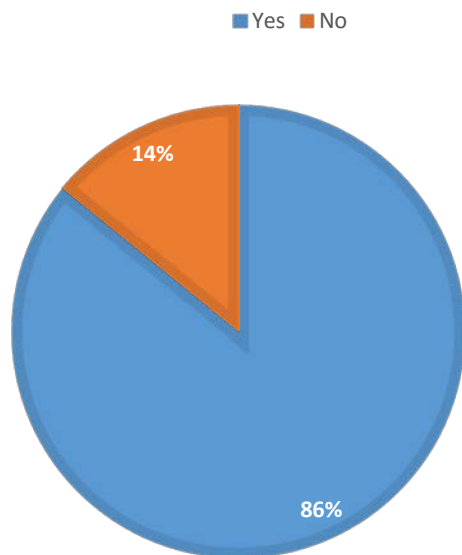

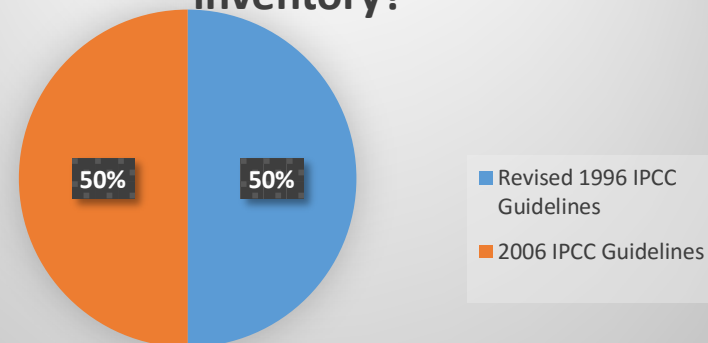

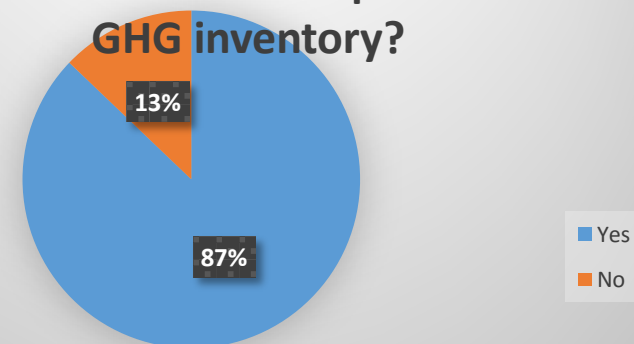

Which guidelines did you use in the preparation of your last GHG inventory?

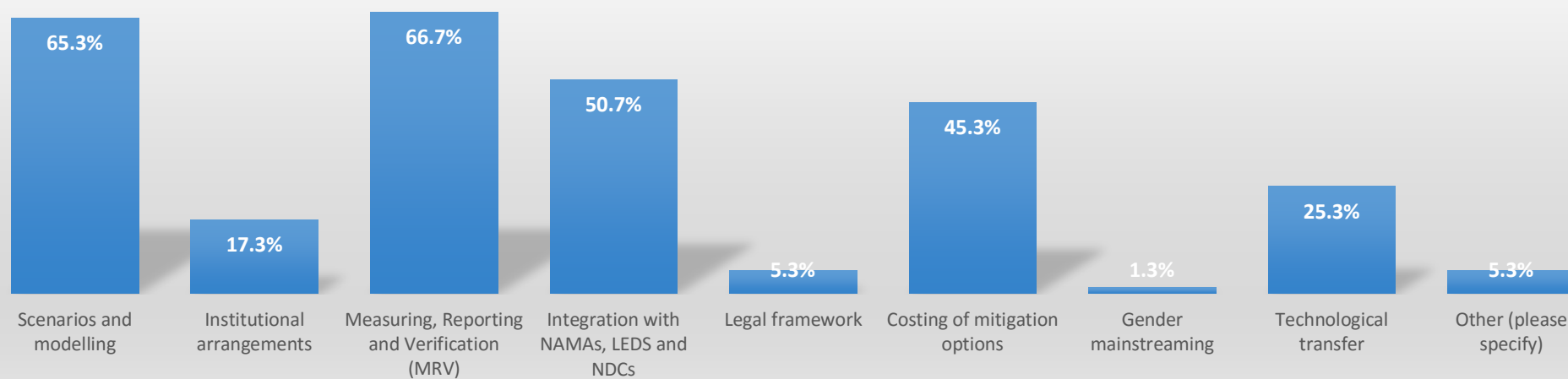


Are you planning to start or continue using the 2006 IPCC Guidelines to develop the next GHG inventory?

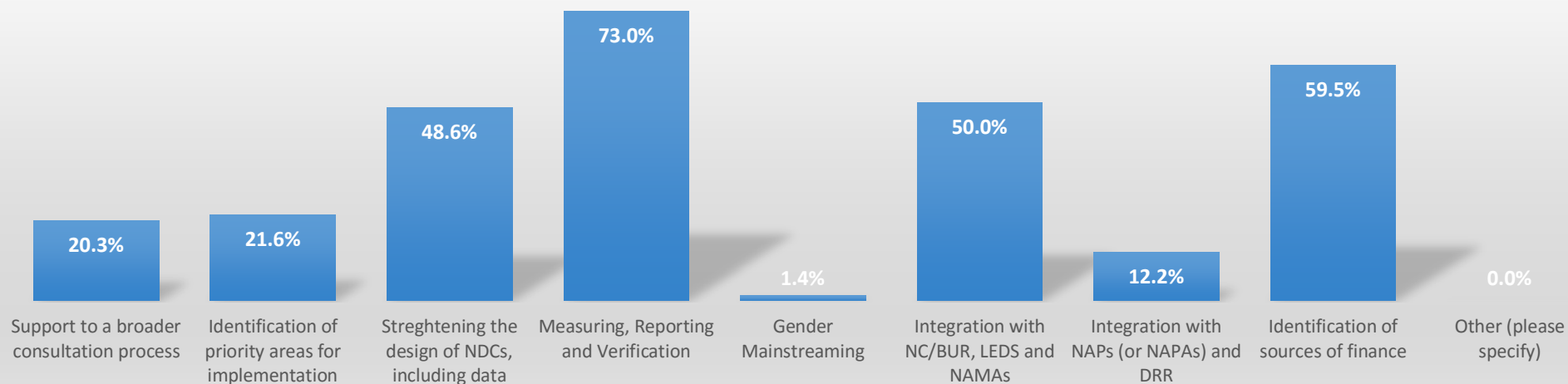
Regarding the mitigation analysis of the NC/BUR, please identify a maximum of 3 areas that your Country may consider as a priority area of improvement





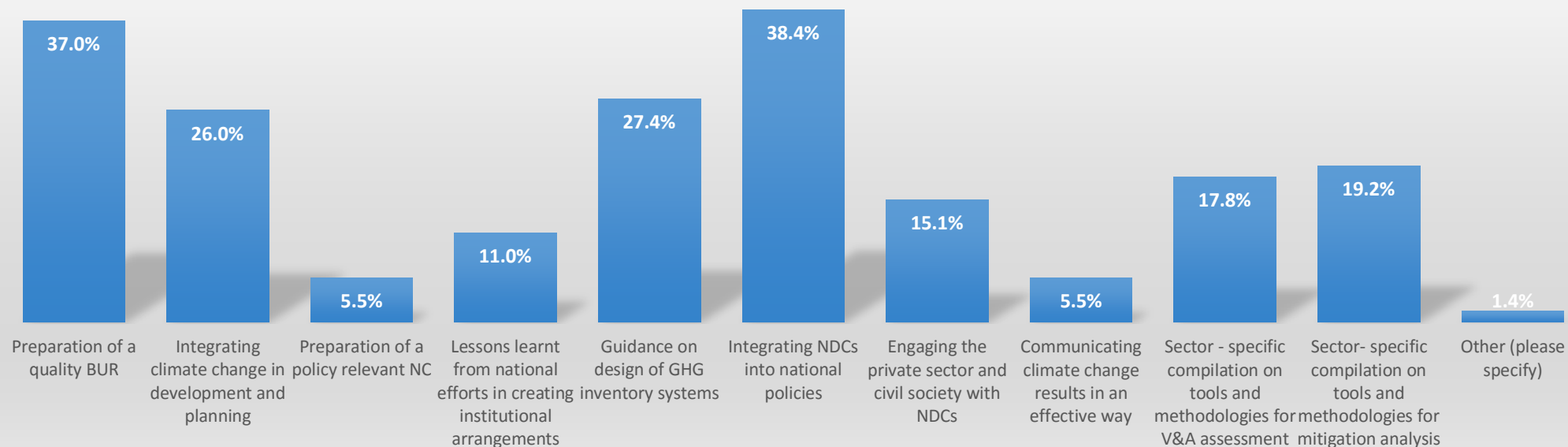
# INDC Support

Regarding NDCs, please identify a maximum of 3 areas where your country may need support



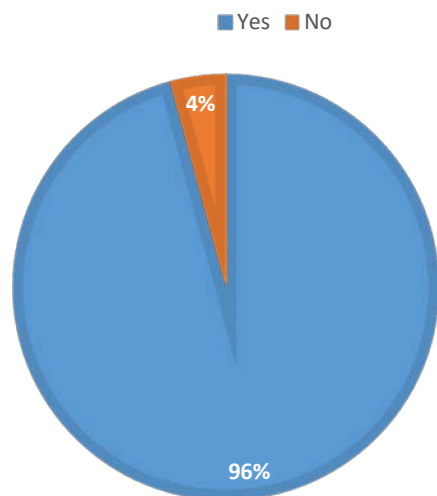

Which would be the two most important guidance notes to be prepared in 2016 by the GSP?

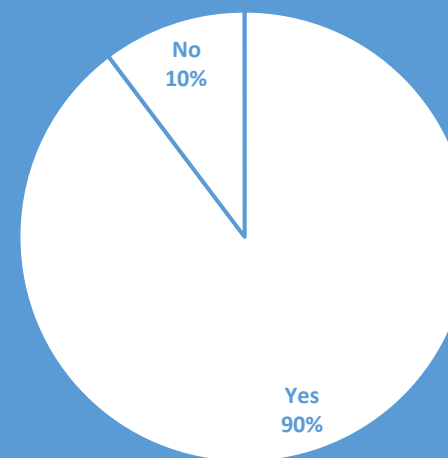
