


- Decision 1/CP.16 Cancun
 - National communications /Biennial Update Reports
- Decision 2/CP.17 Durban
 - Submission of first BUR by December 2014
 - Subsequently every 2 years
 - Inventory year
 - Minimum, no more than four years prior to the date of submission or more recent
 - Subsequent...does not precede by more than four years
 - The ICA process will consist of the following two steps:
 - Technical Analysis (TA)
 - Facilitative Sharing of Views (FSV)
- Decision 18/CP.18
 - Recognized the important role of the CGE in facilitating technical advise and support
- Decision 20/CP.19
 - Requested the CGE to develop and organize appropriate training programmes for nominated technical experts, with a view to improving the technical analysis
