The SBI welcomed the report of the CGE on the "workshop to exchange views on possible elements to be considered in a future revision of the UNFCCC Guidelines for the preparation of national communications from Parties not included in Annex I to the Convention, taking into account the difficulties encountered by non-Annex I Parties in the preparation of their most recent national communications" (21-23 March 2011, Antigua and Barbuda).

- Systematic use of UNFCCC software

The information will be compiled by the secretariat and considered by the SBI 35.
